NOT QUITE invites you to a juried Art salon at "Fengersfors bruk" in Dalsland, Sweden.

We invite artists born in 2000 or earlier to submit artwork on the theme of *Motherland*.

WHO CAN APPLY Individual artists or groups can apply. Born in 2000 or earlier.

TERMS Each applicant may apply with 1–3 works on the subject. If the applicant is a group, 1–3 works for the entire group.

If more than one work is submitted, the jury reserves the right to choose one or two of the art pieces.

THE APPLICATION is made digitally with a maximum of 2 images / artworks (at least 150 dpi, 2000x1500 pixels) and a short text, max thousand characters, which describe the work both in depth and technically.

If it turns out that an accepted artwork differs significantly from the image and description in the application, Not Quite reserves the right to reject the artwork.

ADMISSION NOTICE will be sent to all applicants on June 1, 2018.

THE JURY consists of the artists Britt-Marie Jern and Nina Bondesson. The jury's decision can not be appealed.

VERNISSAGE OPENING July 7 2018 Not Quite, Fengersfors.

SALE The work does not have to be for sale, but if the sale is possible, the commission is 30%.

SUBMISSION OF ACCEPTED WORKS will take place on Not Quite during June 25–July 1, 2018. For more information, please refer to the notice of admission. All assumed works shall be in place by July 1 2018.

TRANSPORTATION The artist provides and transports of accepted works to and from Not Quite him/her-self and is responsible for insurance costs during transportation.

INSURANCE DURING THE EXHIBITION Not Quite has an insurance covering all the current exhibitions. The amount is limited to SEK 300,000 in total. For those who wish for a more comprehensive insurance, we recommend that you get an extra insurance yourself. Please note that the showrooms are unattended.

REGISTRATION FEE SEK 200. Enter *name and nqfosterland* in the message box.

The payment must be at Not Quites disposal no later than April 15, 2018.
