



TERMS & CONDITIONS

Group Bookings

All amounts are charged in SEK (Swedish Krona).

Accepted Online payment methods: Secured online credit card payment (VISA or MasterCard, American Express at an extra fee) or by bank transfer.

From 20 February we only accept credit card payment.

Bookings can be made in between 24-28 March 2020. In case your required arrival- or departure date lies outside the given time period, please book the closest possible date and inform us about the required arrival using the field "special hotel request".

Meetagain will request extra nights in the selected hotel and will confirm them according to the hotel's availability.

Room rate will be confirmed upon availability of the hotel.

All additional room nights will be automatically contracted once confirmed and payment is received in full.

Group conditions apply for all bookings of more than 5 rooms per night.

Payment conditions

Group reservations must pay 30% of the total amount as deposit. Bookings will not be confirmed until deposit payment is received in full. The remaining 70% must be paid no later than **20th December 2019**. Potential additional incidentals, such as mini-bar and telephone, must be paid directly to the hotel upon check-out.

Cancellation policy

All cancellations must be sent in writing and addressed to EAHP2020-housing@meetagain.se.

The hotels will not accept direct changes.

Change fee

All changes (including name changes after name list have been updated) are charged with SEK 500.

Cancellations received up to and including the **20th December 2019** will be refundable, deducted by the 30% deposit.

After this date Meetagain / the hotel is entitled to charge up to 100% of the contracted rate for any cancelled night.

Meetagain tries it utmost to re-sell late cancelled rooms in order to avoid high costs for the participants. In case of a successful re-sale Meetagain will refund any overpaid amounts deducted by an administration fee of SEK 300 net per re-sold night.

Payment by credit card and bank transfer are the only accepted methods of payment. All costs are to be borne by the ordering customer. It is in the companies/agents responsibility to ensure that the deposit amount due can be retrieved within one charge per deposit (=partial charges are not accepted).



Failure to settle payment on due time may result in the full cancellation of your reservation, with no refund of payments previously made.

Final invoice for any additional charges and/or incidentals must be paid directly to the hotel before check out.

The currency exchange rate to be applied in the case of payments and refunds will be based on the available exchange rate at the time of the transaction. The Accommodation Secretariat is not responsible for any changes in exchange rates which may cause any differences or any other additional fees levied by your bank or card processor.

Meetagain is not responsible for and will be exempt from all liability in respect of any loss, damage, injury, accident, delay or inconvenience to any person, his or her luggage for any reason whatsoever on any tourist services provided. Personal travel and health insurance is recommended. Refunds will be processed post conference, for administrative reasons. All bank charges will be deducted from all registration refunds.
