NOTE! If we need to refund, the subscription payment will be made to the cash account, as specified on the registration form.

Origo Quest 1 is a special fund under the act (2013:561) on managers of alternative investment funds. Origo Quest 1 is therefore not to be regarded as a so-called UCITS fund. It is the responsibility of everyone who is interested in Origo Quest 1 to ensure that the

investment is made in accordance with applicable laws and regulations, as well as Swedish. Foreign law may prohibit an investment to made by investors outside of Sweden. The Management Company Origo Capital AB has no responsibility to verify that an investment from abroad is in accordance with the laws of such country. Any dispute or claim concerning the Origo Quest 1 shall be governed by Swedish law exclusively by Swedish courts.
